



Contract for Mare in-foal Shipping Program

As administered by the

Canadian Thoroughbred Horse Society (BC Division) and Hastings Entertainment, Inc.

For each of the first 50 mares in-foal purchased out-of-province and imported to British Columbia the buyer will qualify to receive up to \$1,000 Canadian towards the transportation costs back to BC. This would apply to sales in Ontario, Kentucky, Florida or California. Mares- in-foal purchased in Seattle or Alberta would have their costs reimbursed to the actual amount of the shipping invoice. The buyer must agree to foal the pregnant mare in BC and breed the mare back to a stallion standing in British Columbia in 2009.

The purpose of this program is to import quality mares-in-foal into the Province of British Columbia. The mare must foal in the Province of British Columbia and be bred back to a stallion standing in the British Columbia in the same year. The intent is to have the foals race at Hastings Racecourse and the mares remain in the Province of British Columbia to have other foals, which will also race at Hastings.

The Canadian Thoroughbred Horse Society (BC Division) and/or Hastings Entertainment Inc. reserve the right to refuse an application submitted to this program for any reason. This plan is offered on a one-year basis and will be evaluated for its effectiveness after that time.

The following requirements must be met in order to qualify for this program (*please note that 1/2 the money will be disbursed once the mare in-foal arrives in BC. The other 1/2 will be disbursed after the mare has been bred back to a BC stallion and all the following requirements have been met*):

1. The Buyer must be a current, paid-up member of the Canadian Thoroughbred Horse Society;
2. The Buyer must provide the Canadian Thoroughbred Horse Society (BC Division) with confirmation of purchase together with certification that the mare was believed to be in-foal at the time of purchase;
3. The Buyer must provide a legitimate receipt or invoice for shipping;
4. The Buyer must obtain the signature of the stallion manager as proof that the mare has been bred-back to a BC Stallion.
